



REGULATIONS FOR YOUR FOUR-LEGGED FRIEND

The **Camping Village Grotta del Saraceno** is pleased to welcome your four-legged friends.

Before booking your camping holiday with your pet, **please read carefully what these regulations provide**, and ask for detailed information, in order to avoid discovering too late any unwelcome prohibitions.

The Management reserves the right to immediately remove from the village anyone who fails to comply with even a single point of these regulations:

1. Small and medium-sized dogs and cats (pets) are allowed (maximum 25 kg).
2. The presence of pets, and their number, must be communicated by the owner at the time of booking and again upon arrival. Admission of animals must be authorized by the Management.
3. Pets must comply with current health regulations, proven by the relevant documentation. At check-in, owners must present the animal's health booklet showing up-to-date vaccinations, or a European pet passport / identity card.
4. Pets are only allowed in the pitches and accommodation units within the dedicated pet-friendly area: a maximum of 2 animals per pitch and 2 animals per accommodation unit. The Management reserves the right, at its sole discretion, to apply or not apply the above rules.
5. Pets are allowed to use only the areas specifically designated for them (on the beach, in the exercise/run area). It is forbidden to take animals into all common/shared areas.
6. Pets may board the shuttle buses to the sea only if they are placed in an appropriate pet carrier.
7. It is strictly forbidden to shower dogs inside the sanitary/toilet facilities. Animals must be washed only in the dedicated "pet showers" area available in a reserved zone, indicated on the Village map.
8. All items belonging to your animal (bed, bowls, etc.) must also be washed in the "pet showers" area.
9. Each owner is responsible for ensuring maximum compliance with hygiene and health regulations both inside the facilities and on the pitches. During the stay, pets must always be accompanied for their physiological needs by an adult (a person of legal age). Owners are required to immediately collect and dispose of their animals' droppings using appropriate hygienic bags, which will be provided free of charge upon arrival.

10. Pets are allowed to access the beach only and exclusively within the specifically marked and authorized area. Domestic animals are allowed to swim in the sea, always respecting and maintaining proper distance from other bathers.
11. Always keep your pet on a leash inside the village. The leash must be no longer than 1.5 meters. Owners must also have a properly sized muzzle available, to be used if necessary or upon request for the safety of people and other animals, as well as waste bags and a scoop for collecting droppings.
12. Dogs considered dangerous or reported as such by the competent authorities may be removed from the village at the Management's discretion.
13. Owners must ensure that their animals do not disturb other guests and do not enter other guests' pitches or accommodation units. Dogs whose behavior causes disturbance or damage to other guests and/or to the facility will be immediately removed from the village.
14. Owners are also liable for any damage caused by their animals to property and/or persons, including buildings and their gardens, common public green areas, and the playground. For such damage, the Management reserves the right to request compensation from the owner or keeper of the dog. Our staff will monitor compliance with these rules.

N.B. Guide dogs for the blind are exempt from the above regulations (Law no. 34/1974).
